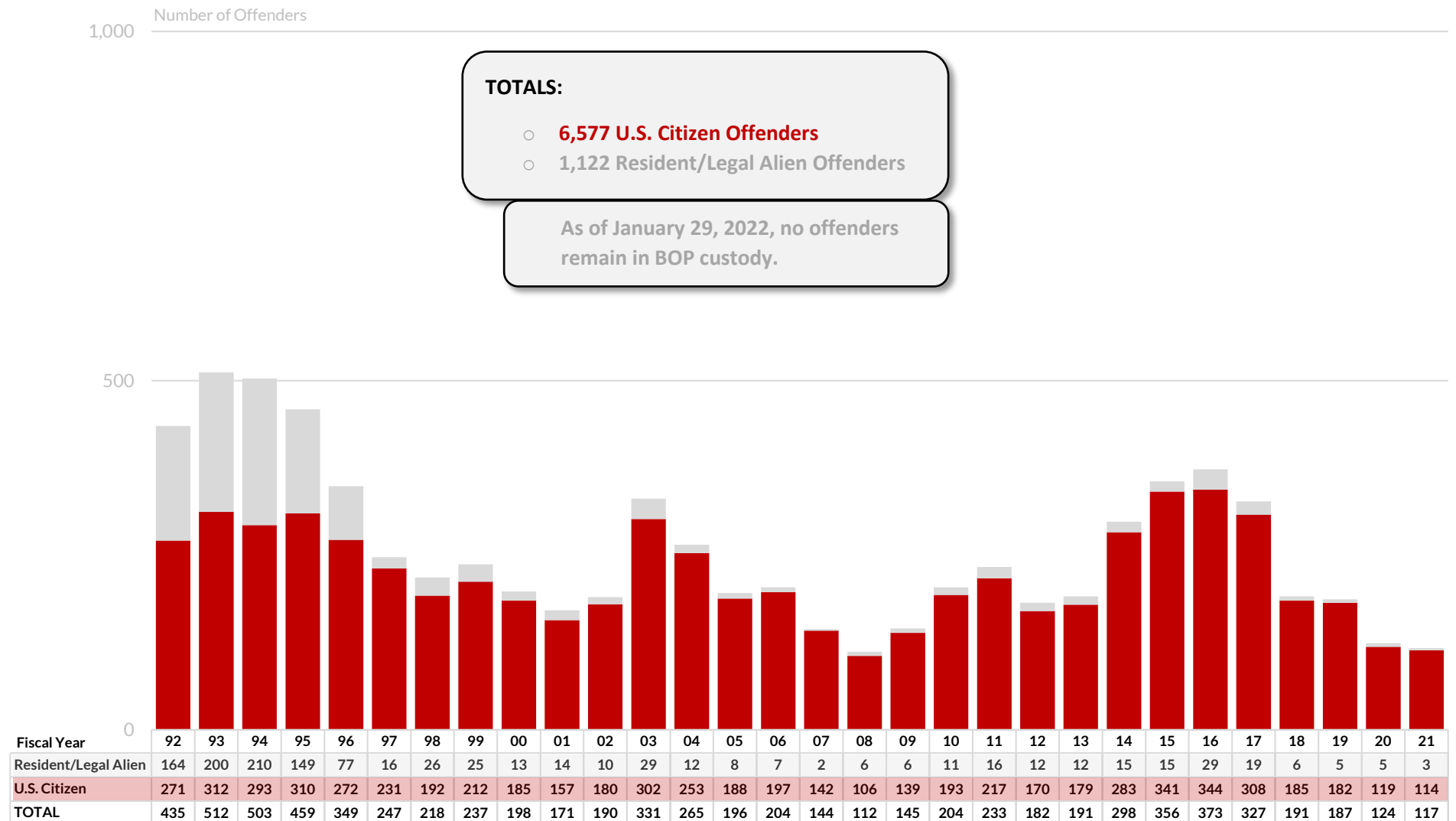


Number of Federal Offenders Convicted Only of 21 U.S.C. § 844 Involving Marijuana Fiscal Years 1992 – 2021

This analysis includes federal offenders whose only count or counts of conviction is 21 U.S.C. § 844, and where the only controlled substance involved in the offense was marijuana.

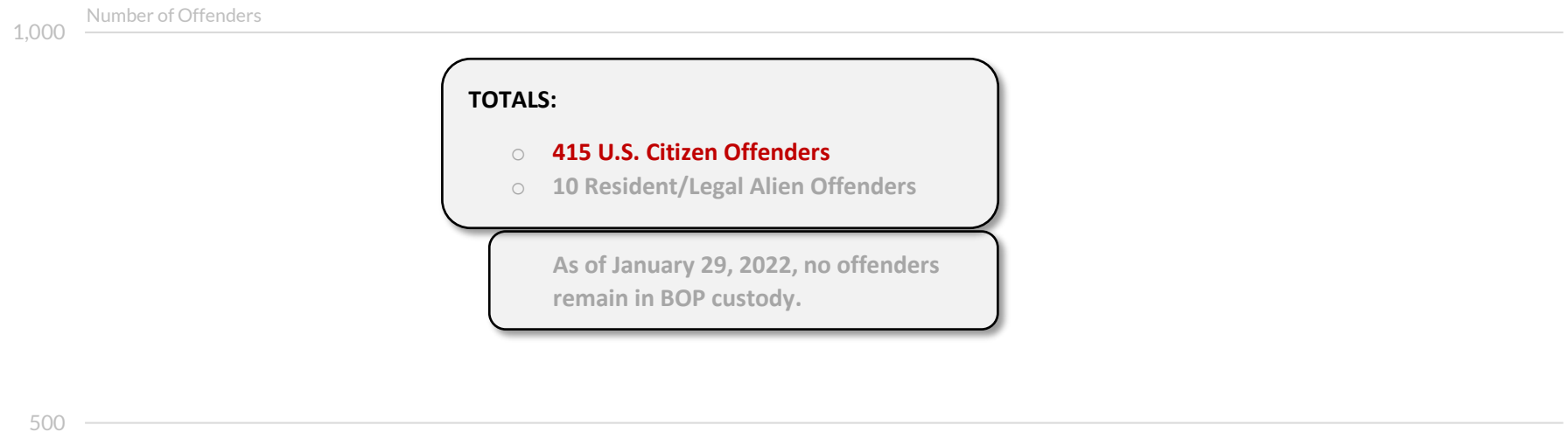

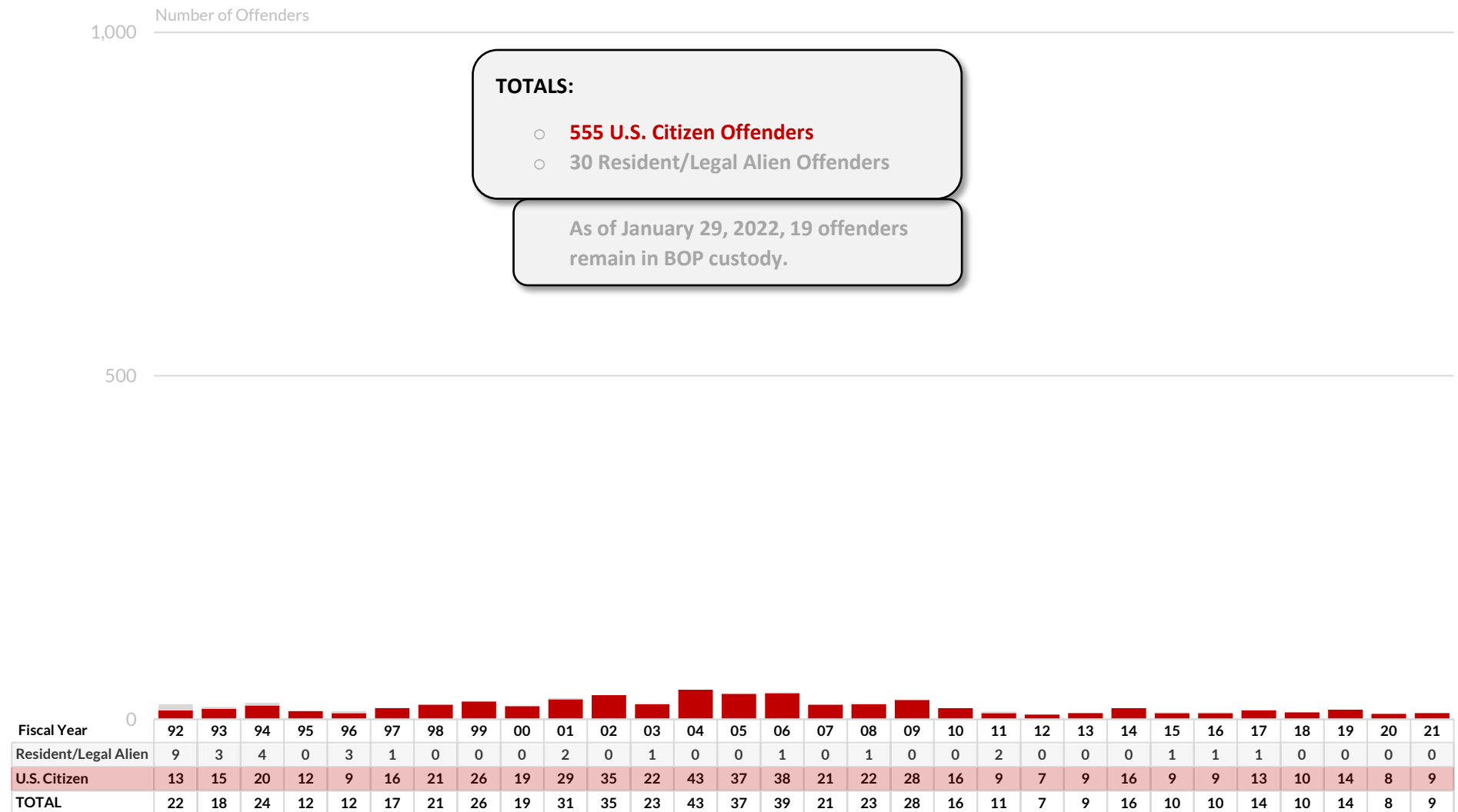

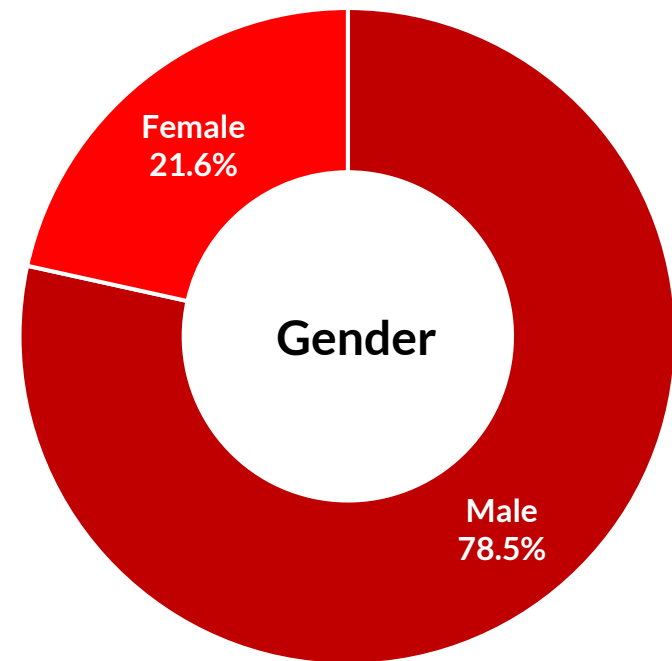
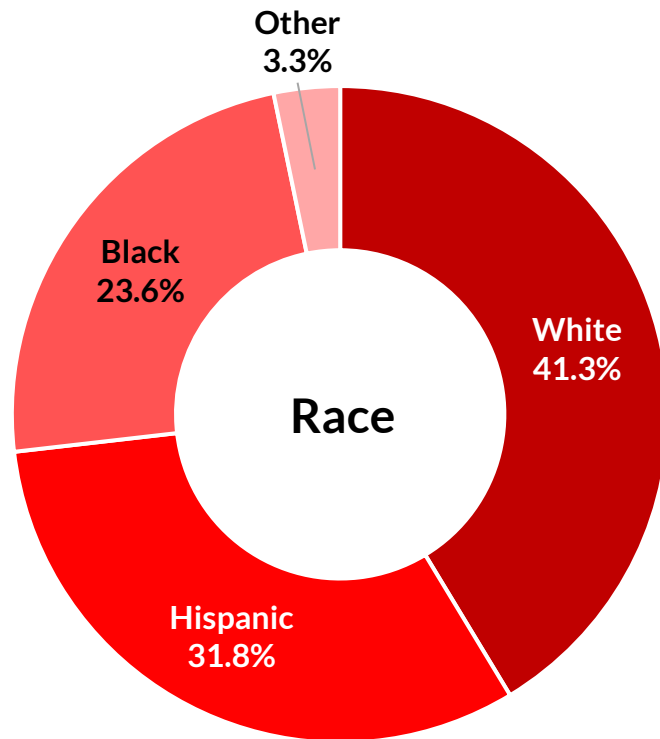

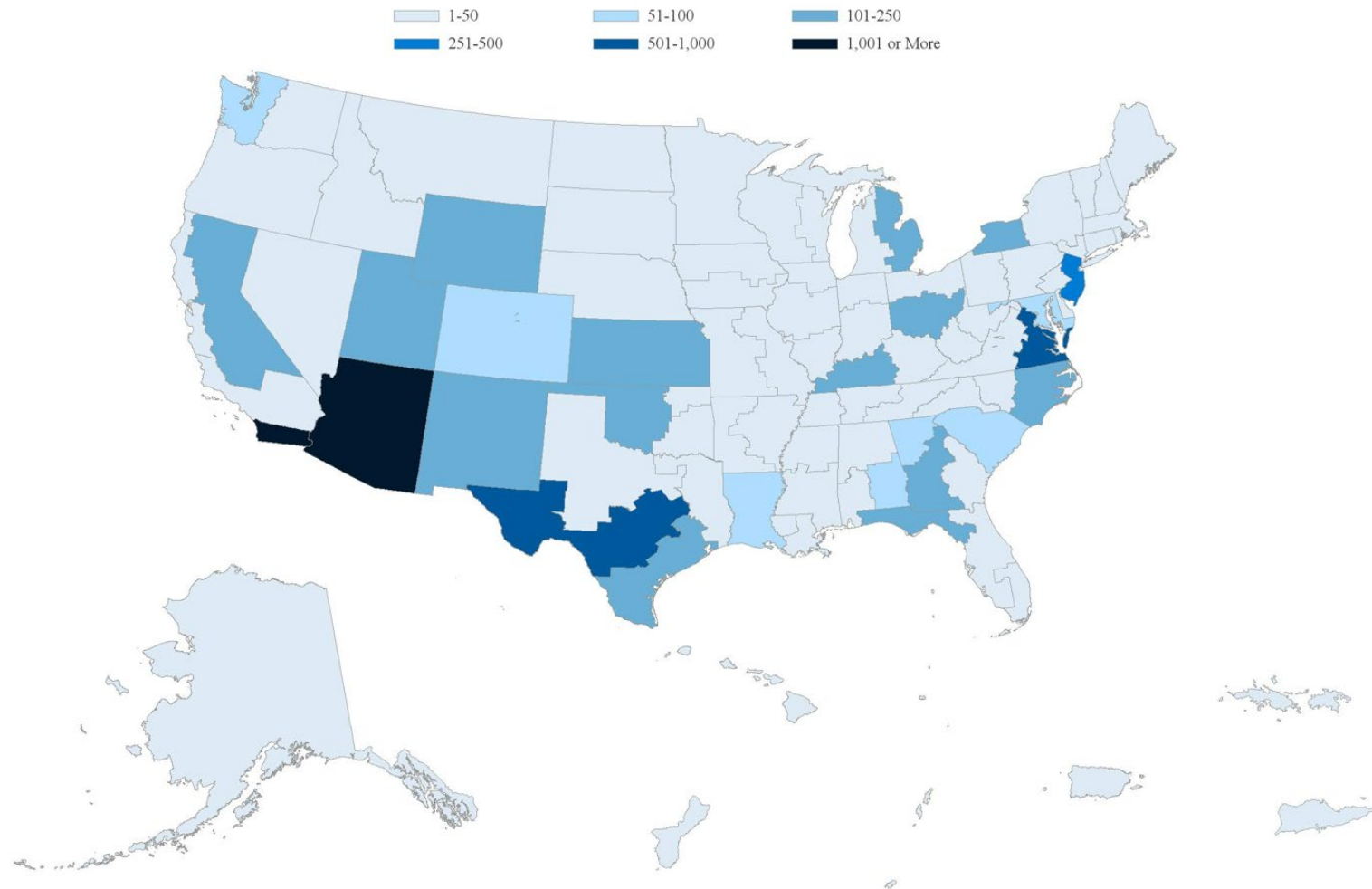
